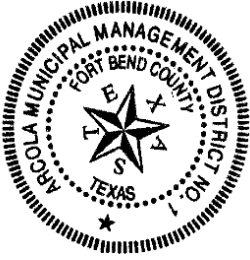


NOTICE OF MEETING

ARCOLA MUNICIPAL MANAGEMENT DISTRICT NO. 1

The Board of Directors (“Board”) of Arcola Municipal Management District No. 1 (“District”) will hold a regular meeting, open to the public, on **Wednesday, November 9, 2022, at 6:00 p.m., at The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas 77478** to discuss and, if appropriate, act upon the items below.

1. Public comments.
2. Minutes.
3. Financial and bookkeeping matters, including:
 - a. payment of the bills; and
 - b. approval of Annual Financial Report.
4. Tax assessment and collections matters including payment of bills.
5. Engineering matters, including:
 - a. authorization of design for projects in the service area.
 - b. approval of plans and specifications and authorization of advertisement for bids for the construction of projects in the service area, including:
 - i. lift station No. 1 to serve the Fenn Road development;
 - ii. offsite utilities to serve the Fenn Road development; and
 - iii. TxDOT Drive Permits along SH-6 and the Post Oak Pointe Development.
 - c. review of bids, award of contracts, and approval of Letter Financing Agreements for construction of projects in the service area, including:
 - i. City of Arcola Lift Station No. 2 Force Main;
 - ii. City of Arcola wastewater treatment plant upgrade; and
 - iii. Post Oak Pointe, Recreation Center.
 - d. approval of pay estimates and change orders and acceptance of projects, as appropriate, for construction of projects in the service area, including:
 - i. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 1 and Post Oak Pointe Drive;
 - ii. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 2;
 - iii. water, sewer, drainage, and paving to serve Post Oak Pointe, Section 3;
 - iv. detention facilities to serve Post Oak Pointe Detention, Phase 2; and
 - v. hardscape & landscape to serve Post Oak Pointe, Phase 1;
 - vi. lift station no. 1 – replacement.
 - e. update on City of Arcola water and sewer plant projects; and
 - f. permits, deeds, easements, consents to encroachment, and utility commitment letters.
6. Garbage collection agreement.
7. Report on development.
8. Update on matters related to Reinvestment Zone Number 1, City of Arcola, Texas.
9. Next meeting date.
