 - iv. City of Arcola Lift Station No. 2;
 - c. review of bids, award of contracts, and approval of Letter Financing Agreements for construction of projects in the service area;
 - d. approval of pay estimates and change orders and acceptance of projects, as appropriate, for construction of projects in the service area, including:
 - i. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 1;
 - ii. Post Oak Pointe Lift Station; and
 - iii. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 2;
 - e. update on City of Arcola water and sewer plant projects; and
 - f. permits, deeds, easements, consents to encroachment, and utility commitment letters.
