

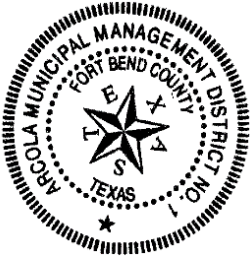
## NOTICE OF MEETING

### ARCOLA MUNICIPAL MANAGEMENT DISTRICT NO. 1

  - b. approval of plans and specifications and authorization of advertisement for bids for the construction of projects in the service area, including:
    - i. water, sewer, drainage, paving, and platting to serve Post Oak Pointe, Section 3; and
    - ii. detention and grading for Post Oak Pointe, Phase 2;
  - c. review of bids, award of contracts, and approval of Letter Financing Agreements for construction of projects in the service area, including:
    - i. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 2;
  - d. approval of pay estimates and change orders and acceptance of projects, as appropriate, for construction of projects in the service area, including:
    - i. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 1; and
    - ii. Post Oak Pointe Lift Station.
  - e. update on City of Arcola water and sewer plant projects; and
  - f. permits, deeds, easements, consents to encroachment, and utility commitment letters.
