

NOTICE OF MEETING

ARCOLA MUNICIPAL MANAGEMENT DISTRICT NO. 1

The Board of Directors (“Board”) of Arcola Municipal Management District No. 1 (“District”) will hold a regular meeting, open to the public, on **Wednesday, September 14, 2022, at 6:00 p.m., at The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas 77478** to discuss and, if appropriate, act upon the items below.

 - i. City of Arcola Lift Station No. 2 Force Main;
 - ii. City of Arcola wastewater treatment plant upgrade; and
 - iii. Post Oak Pointe, Recreation Center.
 - d. approval of pay estimates and change orders and acceptance of projects, as appropriate, for construction of projects in the service area, including:
 - i. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 1 and Post Oak Pointe Drive;
 - ii. Post Oak Pointe Lift Station;
 - iii. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 2;
 - iv. water, sewer, drainage, and paving to serve Post Oak Pointe, Section 3;
 - v. detention facilities to serve Post Oak Pointe Detention, Phase 2; and
 - vi. hardscape & landscape to serve Post Oak Pointe, Phase 1;
 - vii. lift station no. 1 – replacement.
 - e. update on City of Arcola water and sewer plant projects; and
 - f. permits, deeds, easements, consents to encroachment, and utility commitment letters.
