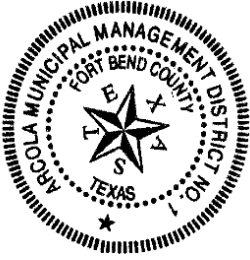


CORRECTED NOTICE OF MEETING

ARCOLA MUNICIPAL MANAGEMENT DISTRICT NO. 1

The Board of Directors (“Board”) of Arcola Municipal Management District No. 1 (“District”) will hold a regular meeting, open to the public, on **Wednesday, August 10, 2022, at 6:00 p.m., at The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas 77478** to discuss and, if appropriate, act upon the items below.

1. Public comments.
2. Minutes.
3. Financial and bookkeeping matters, including payment of the bills.
4. Tax assessment and collections matters including payment of bills.
5. 2022 tax rate, including:
 - a. establishment public hearing date; and
 - b. authorization for appropriate notices regarding proposed tax rate and hearing.

 - i. lift station No. 1 to serve the Fenn Road development; and
 - ii. offsite utilities to serve the Fenn Road development.

 - c. review of bids, award of contracts, and approval of Letter Financing Agreements for construction of projects in the service area, including:
 - i. City of Arcola Lift Station No. 2 Force Main;
 - ii. City of Arcola Lift Station No. 2;
 - iii. City of Arcola wastewater treatment plant upgrade; and
 - iv. Post Oak Pointe, Recreation Center.
 - d. approval of pay estimates and change orders and acceptance of projects, as appropriate, for construction of projects in the service area, including:
 - i. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 1 and Post Oak Pointe Drive;
 - ii. Post Oak Pointe Lift Station;
 - iii. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 2;
 - iv. water, sewer, drainage, and paving to serve Post Oak Pointe, Section 3;
 - v. detention facilities to serve Post Oak Pointe Detention, Phase 2; and
 - vi. hardscape & landscape to serve Post Oak Pointe, Phase 1.
 - e. update on City of Arcola water and sewer plant projects; and
 - f. permits, deeds, easements, consents to encroachment, and utility commitment letters.
7. Report on development.
8. Resolution Adopting Policies and Procedures Regarding Public Comments.
9. Next meeting date.
