

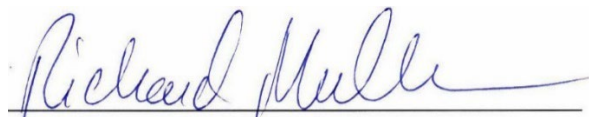
NOTICE OF MEETING

ARCOLA MUNICIPAL MANAGEMENT DISTRICT NO. 1

The Board of Directors ("Board") of Arcola Municipal Management District No. 1 ("District") will hold a regular meeting, open to the public, on **Wednesday, March 9, 2022, at 6:00 p.m., at The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas 77478** to discuss and, if appropriate, act upon the items below.

 - i. City of Arcola Lift Station No. 2 Force Main;
 - ii. City of Arcola Lift Station No. 2;
 - iii. City of Arcola wastewater treatment plant upgrade; and
 - iv. Post Oak Pointe, Phase 1 Entry & Access Road;
 - c. review of bids, award of contracts, and approval of Letter Financing Agreements for construction of projects in the service area, including:
 - i. water, sewer, drainage, paving, and platting to serve Post Oak Pointe, Section 3;
 - ii. detention and grading for Post Oak Pointe, Phase 2; and
 - iii. right turn lane from State Highway 6 onto Post Oak Pointe Drive.
 - d. approval of pay estimates and change orders and acceptance of projects, as appropriate, for construction of projects in the service area, including:
 - i. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 1;
 - ii. Post Oak Pointe Lift Station; and
 - iii. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 2;
 - e. update on City of Arcola water and sewer plant projects;
 - f. permits, deeds, easements, consents to encroachment, and utility commitment letters; and
 - g. Utility Conveyance and Security Agreement.
