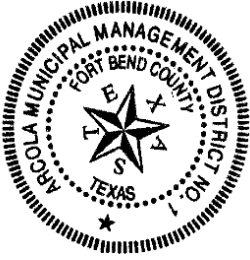
ARCOLA MUNICIPAL MANAGEMENT DISTRICT NO. 1

The Board of Directors (“Board”) of Arcola Municipal Management District No. 1 (“District”) will hold a regular meeting, open to the public, on **Wednesday, March 8, 2023, at 6:00 p.m., at The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas 77478** to discuss and, if appropriate, act upon the items below.

1. Public comments.
2. Minutes.
3. Financial and bookkeeping matters, including payment of the bills.
4. Tax assessment and collections matters, including payment of the bills.
5. Engineering matters, including:
 - a. authorization of design for projects in the service area;
 - b. approval of plans and specifications and authorization of advertisement for bids for the construction of projects in the service area, including Post Oak Pointe, Section 5.
 - c. review of bids, award of contracts, and approval of Letter Financing Agreements for construction of projects in the service area, including:
 - i. City of Arcola Lift Station No. 2 Force Main;
 - ii. lift station No. 1 to serve the Fenn Road development; and
 - iii. offsite utilities to serve the Fenn Road development.
 - d. approval of pay estimates and change orders and acceptance of projects, as appropriate, for construction of projects in the service area, including:
 - i. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 1 and Post Oak Pointe Drive;
 - ii. water, sewer, drainage, paving, and grading to serve Post Oak Pointe, Section 2;
 - iii. water, sewer, drainage, and paving to serve Post Oak Pointe, Section 3;
 - iv. hardscape & landscape to serve Post Oak Pointe, Phase 1;
 - v. lift station no. 1 – replacement;
 - vi. Post Oak Pointe, Recreation Center; and
 - vii. City of Arcola wastewater treatment plant upgrade.
 - e. update on City of Arcola water and sewer plant projects;
 - f. permits, deeds, easements, consents to encroachment, and utility commitment letters;
 - g. authorization to prepare bond application; and
 - h. Utility Conveyance and Security Agreement.

7. Update on matters related to Reinvestment Zone Number 1, City of Arcola, Texas.
8. Next meeting date.
